Children looked after in England (including adoption and care leavers) year ending 31 March 2007

This Statistical First Release (SFR) provides information about children looked after in England for the year ending 31 March 2007. The data is based on returns collected from all 150 local authorities.

The tables show national totals for:

- children looked after at 31 March 2007.
- > children who started to be looked after during the year ending 31 March 2007
- > children who ceased to be looked after during the year ending 31 March 2007
- > children looked after who were adopted during the year ending 31 March 2007
- children who ceased to be looked after aged 16 years and over during the year ending 31 March 2007
- children now aged 19 years who were looked after on 1 April 2004, then aged 16 years
- children aged under 16 years who have been looked after continuously for at least two and a half years (Public Service Agreement target 5 of Spending Review 2004)

New information is presented on the number, the legal status, and the gender of the adopter(s) of children looked after who were adopted in the year ending 31 March 2007.

KEY POINTS

Children looked after at 31 March 2007 - Tables A1 to A5

- 60,000 children were looked after at 31 March 2007 which is broadly the same as the previous year's figure of 60,300 and a decrease of 2 per cent from 2003 (61,200).
- Overall, the main reason why social services first engaged with these children looked after was because of abuse or neglect (62 per cent). This percentage has changed little over the past 5 years.
- Most children looked after at 31 March 2007 were of White British origin.
 Their number and percentage has decreased over the last 5 years from 47,300 (77 per cent) in 2003 to 44,700 (74 per cent) in 2007.
- At 31 March 2007, 38,600 children were looked after under a care order which represents 64 per cent of all legal statuses. This is a decrease of 2 per cent from last year's figure of 39,500 and a decrease of 5 per cent from 2003 (40,500). 4 per cent of children were looked after under a placement order.
- 42,300 children looked after at 31 March 2007 were in a foster placement (71 per cent). This is an increase of 2 per cent on the previous year's figure of 41,700 and an increase of 3 per cent from 2003 (41,000).



Unaccompanied Asylum Seeking Children (UASC) - Table A4

- 3,300 UASC were looked after at 31 March 2007. This figure has changed little over the last four years however it represents an increase of 49 per cent from the 2003 figure of 2,200.
- Except at 31 March 2003, most UASC were aged 16 years and over.
- At 31 March 2007, 31 per cent of UASC were of African origin. This represents a decrease of 4 percentage points from the 2003 figure of 35 per cent. 22 per cent were from other Asian backgrounds which represents an increase of 16 percentage points from the 2003 figure of 6 per cent. 21 per cent were from other ethnic groups which represents a 5 percentage point increase on the 2003 figure of 16 per cent.

Mothers aged 12 and over – Table A5

 There were 360 mothers aged 12 and over who were looked after at 31 March 2007, an increase of 15 per cent from the previous year's figure of 310 and an increase of 20 per cent from the 2005 figure of 300.

Children who started to be looked after during the year ending 31 March 2007 – Tables C1 to C3

- There were 23,700 children who started to be looked after during the year ending 31 March 2007, a
 decrease of 3 per cent from the previous year's figure of 24,600 and a decrease of 5 per cent from
 the 2003 figure of 24,900.
- During the year ending 31 March 2007, 39 per cent of children who started to be looked after were aged between 10 and 15 years old. This figure has decreased over the past 5 years.
- The percentage of children who started to be looked after in the year ending 31 March 2007 who
 were white British has decreased over the last 5 years from 73 per cent in 2003 to 67 per cent in
 2007.

Children who ceased to be looked after during the year ending 31 March 2007 – Tables D1 to D3

- There were 24,700 children who ceased to be looked after during the year ending 31 March 2007, a decrease of 5 per cent from the previous year's figure and the figure for 2003 was broadly the same as the 2007 figure.
- The percentage of children who ceased to be looked after aged between 5 and 9 years old as well as aged between 10 and 15 years old decreased over the last 5 years from 17 per cent in 2003 to 14 per cent in 2007 and from 30 per cent in 2003 to 26 per cent in 2007 respectively. However, the percentage of children who ceased to be looked after aged 16 and over increased over the past 5 years from 27 per cent in 2003 to 33 per cent in 2007.
- The proportion of children of white British ethnic origin who ceased to be looked after decreased from 76 per cent in 2003 to 68 per cent in 2007 whereas the proportions of children from other Asian backgrounds and of African ethnic origin have increased from 1 per cent in 2003 to 3 per cent in 2007 and from 4 per cent in 2003 to 6 per cent in 2007 respectively.
- In the year ending 31 March 2007, most children who ceased to be looked after had a foster placement as their final placement (12,600). This represents 51 per cent of all final placements.

Mothers aged 12 and over who ceased to be looked after – Table D3

• There were 370 mothers aged 12 and over who ceased to be looked after during the year ending 31 March 2007, an increase of 24 per cent from the previous year's figure of 300.

Children looked after who were adopted during the year ending 31 March 2007 – Tables E1 and E2

- 3,300 children looked after were adopted during the year ending 31 March 2007. This represents a 11 per cent decrease from the previous year's figure of 3,700 and a 7 per cent decrease from the 2003 figure of 3,500.
- The number of children looked after who were under 1 year old at adoption decreased over the last 5 years from 220 in 2003 to 150 in 2007.
- The percentage of children looked after who were adopted that were of white ethnic origin decreased over the past 5 years from 87 per cent in 2003 to 85 per cent in 2007, whereas the percentage of mixed ethnic origin children looked after who were adopted increased over the same period from 8 per cent in 2003 to 10 per cent in 2007.
- Before being adopted in 2007, 38 per cent of these children were looked after under a freed for adoption final legal status, 36 per cent were looked after under a care order and 19 per cent were looked after under a placement order.
- The average duration of the final period of care that children looked after had before being adopted in 2007 was 2 years and 8 months. This has changed little over the past 5 years.

New information collected this year's data collection: Adopters of children looked after who were adopted in the year ending 31 March 2007 – Table E2

- 91 per cent of children looked after who were adopted in 2007 were adopted by two people (3,000).
 Most adopters were married (84 per cent), 4 per cent of adopters were an unmarried couple (different gender), 2 per cent of adopters were an unmarried couple (same gender) and 1 per cent of adopters were civil partners.
- 9 per cent of children looked after who were adopted in 2007 were adopted by a single adopter. 94
 per cent of single adopters were female.

Children who ceased to be looked after aged 16 years and over during the year ending 31 March 2007 – Table F1

- The number of children aged 16 years and over who ceased to be looked after during the year ending 31 March increased from 6,700 in 2003 to 8,200 in 2006 and decreased to 8,000 in 2007.
- 58 per cent of these children ceased to be looked after on their 18th birthday, 25 per cent ceased to be looked after aged 16 years.
- The percentage of children aged 16 and over who ceased to be looked after during the year ending 31 March of white British ethnic origin decreased from 73 per cent to 60 per cent over the last 5 years whereas the percentage of those from other Asian backgrounds and of African ethnic origin

increased respectively from 1 per cent in 2003 to 5 per cent in 2007 and from 6 per cent in 2003 to 10 per cent in 2007.

- Before ceasing to be looked after during the year ending 31 March 2007, 3,100 children aged 16 and over were in a foster placement (38 per cent), 2,100 in secure units, children's homes and hostels (27 per cent) and 1,800 were placed in the community (23 per cent).
- In 2006-07, 44 per cent of these children had at least 1 GSCE or GNVQ (3,500) and 7 per cent of the 8,000 children obtained at least 5 GCSEs at grade A* to C.

Children now aged 19 years who were looked after on 1 April 2004 then aged 16 years – Tables G1 and G2

- The number of children now aged 19 years who were looked after on 1 April 2004 then aged 16 years increased from 4,900 in 2003 to 5,800 in 2007.
- Over the past 5 years, the percentage of children now aged 19 years who were in education other than higher education increased from 15 per cent to 26 per cent. The number for those who were in training or employment increased from 1,400 to 1,800 between 2003 and 2007. Finally, the number for those who were not in touch with the local authorities decreased from 20 per cent to 8 per cent.
- Most children now aged 19 years who were looked after at 16 years were accommodated in independent living. This percentage increased from 37 per cent in 2003 to 43 per cent in 2007.

Updated Historical data on Mothers aged 19 years during the year ending 31 March 2006 who were looked after on 1 April 2003 then aged 16 years – Table G2

• There were 400 mothers aged 19 years during the year ending 31 March 2006 who were looked after on 1 April 2003 then aged 16 years.

Children aged under 16 years who have been looked after continuously for at least two and a half years – Table H1

 66 per cent of children aged under 16 years who have been looked after continuously for at least two and a half years were in the same placement for at least two years, or were placed for adoption.

This relates to the Public Service Agreement (PSA) target which is to narrow the gap in educational achievement between looked after children and that of their peers, and improve their educational support and the stability of their lives so that by 2008, 80 per cent of children under 16 who have been looked after for two and a half years or more will have been living in the same placement for at least two years, or are placed for adoption.

Notes to editors

- 1. The 2006-07 figures for children looked after are the latest in a regular series. Data are collected on the SSDA903 return, which provides the Department for Children, Schools and Families with data on children looked after in England. It also covers adoptions of looked after children, educational qualifications of care leavers, the activity of former care leavers aged 19, and the Public Service Agreement target 5 of the Spending Review 2004.
- 2. All references made to "year" relate to the standard financial year which runs from 1 April to 31 March (for example 2007 should be understood as 1 April 2006 to 31 March 2007).
- 3. New data were collected on the number, gender, and legal status of the adopters of children looked after who were adopted during the year ending 31 March 2007.
- 4. The figures presented for the year ending 31 March 2007 are based on data reported by all 150 local authorities in England.
- 5. The database used to collect this information is longitudinal with one record for every child. As local authorities are continually updating the database every year, previous years figures have also been amended where there have been changes (see footnotes on historical changes in the relevant tables).
- 6. Between 1997-98 and 2002-03 local authorities were required to submit a CLA100 return along with the SSDA903 return. The CLA100 was an aggregate return completed for all children looked after at 31 March while the SSDA903 was a one-in-three sample survey. From year ending 31 March 2004, the SSDA903 covered all children looked after and so the CLA100 was not required.
 - Between 1997-98 and 2002-03, the AD1 return was completed for all children looked after who were adopted during the year; the OC1 return collected data on the qualifications achieved at the point of leaving care for young people leaving care in the year aged 16 and over; and the OC3 return collected data on the activity and accommodation of former care leavers at age 19 who were looked after on 1 April aged 16 years old (in their 17th year). From year ending 31 March 2004, these returns were collected as part of the SSDA903 data collection and so are not referred to as such anymore.
- 7. Figures have been rounded to the nearest 100 if they exceed 1,000 and to the nearest 10 otherwise, with the exception of numbers from one to five inclusive which for confidentiality purposes have been replaced in the published tables by a hyphen (-). Where any number is shown as zero (0), the original figure submitted was zero (0). The following convention has been used: "X" means not applicable.
- 8. Percentages have been rounded to whole numbers unless the numerator was five or less or the denominator was 10 or less, in which case they have been suppressed and replaced by a hyphen (-). Note that percentages may not sum to 100 due to rounding.
- 9. It has been necessary to suppress other figures whenever it would be possible to calculate the value of a suppressed number by means of simple arithmetic. The rule applied in these circumstances has been to suppress the next smallest data item provided its value is strictly less than 20.
- 10. This publication is one of two children's social services publications being released at the same time. The other covers children on the Child Protection Register and is entitled Referrals, Assessments and Children and Young People who are the subject of Child Protection Plans (on the Child Protection Register), England Year ending 31 March 2007.
